

The Lottery Office High Ball Challenge

Gold Coast Titans & The Lottery Office Terms and Conditions

- 1. The promoter is Global Players Network Pty Ltd (ABN 41 102 371 335) t/a The Lottery Office of 203 Robina Town Centre Drive, Robina, Queensland, 4226 (Promoter). The Promoter and its related companies are referred to as the Promoter Group.
- 2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of the Promoter's terms and conditions.
- 3. Entry to the promotion is free and open to residents of Australia who are 18 years of age or older that are invited to compete for 'The Lottery Office High Ball Challenge'.
- 4. Entry to the promotion is open between the 'Draw times and Dates' listed below:

- 5. Entrants can have only one entry in the promotion.
- 6. To enter, entrants must:
 - a) Enter the competition as advertised on The Lottery Office social pages, either via Facebook or Instagram, or;
 - b) Enter the competition as advertised on the Hot Tomato broadcasts (ie radio), social pages either via Facebook, Instagram, or website.
- 7. Directors, managers, agents, employees of the Promoter Group and their immediate families are not eligible to win any prizes resulting from this promotion.
- 8. One winning entry will be drawn by the Promoter for each Promotion Date at the 'Draw times and Date' listed in clause 4 and the other entry by Hot Tomato in accordance with their competition terms and conditions. The Promoter reserves the right to alter the respective Promotion Date owing to early or late conclusions of the respective Gold Coast Titans matches.
- 9. The first two valid entries drawn in each Promotion Date will win the chance to catch for the prizes (Contestants). The Promoter's decision as to the result of the prize is final and no correspondence will be entered into.
- 10. The Promoter will attempt to notify each prospective Contestant via telephone, socials and/or email immediately after the draw times listed in clause 4.
- 11. If a Contestant is unable to be contacted within 24 hours after the draw time, then that person's right to being a Contestant and winning the prize is forfeited. The Promoter will conduct further draws as are necessary in order to select a contestant for the competition as determined by the Promoter in its absolute discretion, subject to any directions given by a responsible authority under any relevant legislation (if applicable). In the event that a further draw is required, the Promoter will also attempt to notify the subsequent winning entry, in accordance with clause 10.
- 12. All Contestants will receive four (4) Premium Grandstand tickets at CBUS Super Stadium. The retail value for this prize is A\$392.
- 13. In the event Contestants do not attend the respective Gold Coast Titans match at the date and time in which they have been drawn to participate, then that person's right to being a Contestant and winning the prize in clause 14 is forfeited and the Promoter will select at random an attendee from the audience at the respective Gold Coast Titans game in order to select a Contestant for the competition as determined by the Promoter in its absolute discretion, subject to any directions given by a responsible authority under any relevant legislation (if applicable). In addition, if a Contestant is unable to participate in "The Lottery Office High Ball Challenge" due to illness, mobility issues or otherwise, at the sole discretion of the Promoter, the Contestant may nominate a representative (Representative) to compete on their behalf. The Representative must be 18 years of age or older to compete. If, the Representative wins, the prize will be awarded to the winning Contestant not the Representative.
- 14. At the designated half time break in each match, the Contestants for each Promotion Date will come onto the playing field and each be given an opportunity to catch a high ball (which will either be kicked by someone on behalf of Gold Coast Titans or launched using a 'bomb' machine). Contestants will compete against each other, by catching as many high balls as possible, in 60 seconds. The Contestant with the most catches in 60 seconds wins the prize. The Promoter's decision as to a successful catch is final. In the event of a tie after each Contestant has completed their 60

seconds of catching, the total cash prize will be equally split between the two Contestants. The total cash prize is A\$1,000.

- 15. The following conditions apply to the prize:
 - a. The prize will be deposited into the prize winner's bank account within three (3) business days of the Promoter being provided with their account details;
 - b. The prize is limited to those outlined in clauses 12 and 14, and any additional costs or charges must be paid by the winner;
 - c. The prize is limited to persons who are 18 years of age or older;
 - d. The prize winner must do everything required of them to accept and take delivery of the prize within a reasonable period of time;
 - e. If the prize winner fails to comply with clause 15(d), their right to the prize will be forfeited and they will not be compensated in any way;
 - f. If the prize (or a component of it) is not available for any reason, the Promoter reserves the right to substitute the prize with another of similar value, or at its discretion, with a cash sum equivalent to the retail value of that component of the prize; and
 - g. The right to the prize is not transferable or assignable to another person.
- 16. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
- 17. If the Promoter reasonably considers that a change to these terms and conditions is necessary due to a change in law, regulations, licence agreement or code and is for the benefit of an entrant, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions and provide reasonable notification at all places where these terms and conditions are made available to entrants.
- 18. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.
- 19. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
- 20. If the Promoter is prevented from or delayed in performing an obligation due to a Force Majeure event then the obligation is suspended during, but for no longer than, the period the Force Majeure event continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
- 21. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay, modify or cancel (if need be) any aspect of this promotion, in its sole discretion due to health, safety, technological or other reasons beyond the Promoter's reasonable control.
- 22. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the

entrant with information and marketing material about products and services of the Promoter Group; and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information.
